IV. Statement of Public Notice

This was a regular meeting of the Board of Education of Bernards Township. Notice of the time and place of this meeting was provided and copies of that resolution were forwarded to the official newspapers as designated by the Board of Education and to the Township Clerk and a copy of the notice was posted on the bulletin board of the Board of Education Offices in accordance with P.L. 1975 Chapter 231A.

We very much welcome input from the public. There are two times during regular meetings that the public is invited to speak. One time is early in the meeting before the Board votes, and you may speak about any item that is listed on tonight's agenda. Towards the end of the meeting, there is another public forum to address any topic whatsoever.

When you approach the microphone, please state your name and address. We do not have a specific time limit, but we ask that you keep your comments brief. Please understand that our public forums are not structured as question and answer sessions, but rather they are offered as opportunities to share your thoughts with the Board. In instances where the Board feels that there is a misunderstanding or inaccuracy, a member of the Board or Administration will address it in the Board Response portion of the agenda.

There are times when a member of the public makes a comment or asks a question about an employee. New Jersey statute does not permit us to discuss

personnel issues in public. Also as a matter of law, a Board of Education may only vote for or against the hiring of an employee upon the recommendation of the superintendent. If the superintendent does not recommend a person, that person's name is not listed on the agenda and there is no vote on that action. If it is necessary for the Board to go into executive session at the end of the meeting, we will provide an estimated length of time for the session and whether any action is anticipated to be taken upon returning to public session.

V. Student Representative's Report

Student Representative Mark Schroeder stated the spring sports season has begun, Senior prom bids have gone on sale, the date of the Junior Prom is May 12 and the opening of the 700 wing was on March 24.

VI. Construction Management Update

Dan Del Mar of Epic Management, Inc. updated the Board of Education on the auditorium, music/dance area and gymnasium project at the high school. The certificate of occupancy for the auditorium will be issued on April 8 with construction immediately beginning on the conversion of the current auditorium into office space.

VII. Public Hearing 2008-09 School Budget

1) Superintendent Valerie A. Goger and Finance Committee Chairperson Janet Smith reviewed the budget process and presented the final 2008-09 school budget. Elements covered included enrollment, class size, hiring of additional staff, technology and the impact the approved cap waiver had on budget planning. Dr. Goger explained that the final budget submitted to the county office needed to have some accounts revised in order to accommodate the final cap waiver approved by the Commissioner in the amount of \$506,318. Ms. Smith also explained the use of the \$2.4M interest earned to fund one-time capital projects and the impact on future budgets if these monies were used to reduce the tax impact for the upcoming budget.

Comments were made on utilization of interest monies and funding of additional staff.

The Finance Committee was acknowledged for their thorough and diligent work in preparing the budget.
