**V. Statement of Public Notice**

This was a regular Meeting of the Board of Education of Bernards Township. Notice of the time and place of this meeting was provided and copies of that resolution were forwarded to the official newspapers as designated by the Board of Education and to the Township Clerk and a copy of the notice was posted on the bulletin board of the Board of Education Offices in accordance with P.L. 1975 Chapter 231A.

We very much welcome input from the public. There are two times during regular meetings that the public is invited to speak. One time is early in the meeting before the Board votes, and you may speak about any item that is listed on tonight's agenda. Towards the end of the meeting, there is another public forum to address any topic whatsoever.

When you approach the microphone, please state your name and address. We do not have a specific time limit, but we ask that you keep your comments brief. Please understand that our public forums are not structured as question and answer sessions, but rather they are offered as opportunities to share your thoughts with the Board. In instances where the Board feels that there is a misunderstanding or inaccuracy, a member of the Board or Administration will address it in the Board Response portion of the agenda.

There are times when a member of the public makes a comment or asks a question about an employee. New Jersey statute does not permit us to discuss personnel issues in public. Also as a matter of law, a Board of Education may only vote for or against the hiring of an employee upon the recommendation of the superintendent. If the superintendent does not recommend a person, that person's name is not listed on the agenda and there is no vote on that action. If it is necessary for the Board to go into executive session at the end of the meeting, we will provide an estimated length of time for the session and whether any action is anticipated to be taken upon returning to public session.

**VI. Student Representative's Report**

Student Representative Mark Schroeder updated the Board on Homecoming weekend. Approximately 800 students attended the dance with an anticipated profit of \$4,500. The Powder Puff football game is scheduled for November 6. The Student Council is discussing the possibility of a Spirit Week the week prior to the Winter Recess.

## VII. Construction Management Update

Dan Del Mar of Epic Management, Inc. updated the Board and public on the status of construction projects within the district. Only punchlist items remain to be completed at the three elementary buildings. Mr. Del Mar's slide show reviewed the high school project progress to date and what to anticipate in the next phases. Questions from the Board included access to the new addition at the atrium location, anticipated completion date of the work at the high school, status of punchlist and the Oak Street gym floor.

### **XIV. Board Forum**

Chairperson of the Facilities Committee Lou Carlucci updated the full Board on the committee meeting held prior to the Board meeting. He stated there were two items that did not require a formal vote by the Board but rather a show of hands to proceed with the projects.

A discussion followed on the construction of a warehouse to store district supplies and equipment at a cost of \$235,321. The administration would like construction to begin prior to the onset of winter. The Board discussed the inclusion of heat, gas and electricity in the building. Mr. Carlucci stated that the committee discussed the expense, space needs within the district, storage plans and inclusion of utilities. The proposed warehouse would be approximately 4,000 square feet and it was noted that the warehouse that was razed was approximately 2,700 square feet.

After discussion, the Board approved the administration proceeding with the proposed 4,000 square foot warehouse at a cost of \$235,321 as follows:

Mr. Carlucci proposed a second item discussed by the Facilities Committee to repave the macadam paths surrounding Ridge High and Cedar Hill Schools. The paths would be paved uniformly to a width of 8 feet and approximately 1,400 feet of length. The construction at the high school has changed the traffic pattern for delivery and emergency vehicles. To provide the necessary access it has been recommended that repaving begin prior to the winter. The low bidder cost for this project is \$108,320. Discussion followed on the advantages/disadvantages of paving now or waiting until the spring. A concern of a pattern change at the completion of construction could mean additional paving would be required in the spring while waiting may increase the price.

A spreadsheet on associated projects was reviewed by the Board and will be updated monthly. Funding for at courtyard a Ridge High, a playground at Mount Prospect School and landscaping at the high school were mentioned as well as the grading system and report card revisions at the K-5 level.

Governor Corzine has named Ms. Trudy Doyle former Superintendent in Bedminster to the position of Somerset County Executive Superintendent.

Mr. Koch stated the November 12 Board meeting will be held in the Board of Education building.
