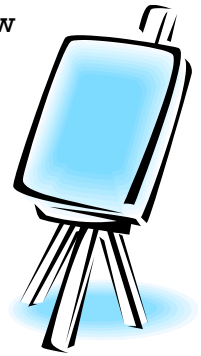

#### **Entry Rules**

- This is a non-juried art exhibit.
- Only individuals residing in Bernards Township are eligible to submit artwork.
- Artists must be age 18 or older.
- Limit of two pieces per artist. *If space permits, artists will be contacted should they wish to submit up to 4 pieces.*
- Artwork can include, but is not limited to, watercolors, oils, acrylics, photography, pastels, drawings, mixed media, and sculpture.
- Hanging artwork must be dry, wired and ready for hanging on drop off day. Frames should be sturdy and plexiglass is preferred. Size limit per piece is 32" x 40", framed.
- If you are submitting 3D artwork, you must provide your own stand.
- Artwork must be family friendly. The Parks & Recreation Department reserves the right to reject artwork for any reason.
- You may indicate your artwork is for sale on the Entry Form. Visitors will be given the contact information you provide, should they be interested in purchasing artwork. The Township will not arrange sales.

**Statement:** I understand that the Somerset County Park Commission will provide insurance for exhibits that are displayed in the Environmental Education Center Building, 190 Lord Stirling Road, Basking Ridge, on an excess basis, in the total amount of \$25,000 (for entire exhibition). **The maximum limit for any one item of artwork on display is \$1,500. There will be a \$250 deductible for each item.** The County of Somerset and the Somerset County Park Commission Environmental Education Center will not be responsible for any artwork left on the premises after 48 hours following the scheduled closing date of the exhibition.
