VII. Student Representative – Gordon Li

Mr. Li provided an update on the Ridge High School student body. Mr. Li discussed the end of AP and standardized testing, the Ridge Forensics achievements, a recent fundraiser by the Ridge Golf Team, other club updates, a Ridge Activities fair to promote clubs, accomplishments of the Ridge Latin Club, upcoming elections for the 2022-23 Student Government and expressed the excitement at the end of the school year.

VIII. Board President Comments

President McKeon invited the public to the rescheduled Bernards Connect Meeting that will be held on June 6, 2022 in the Ridge High School cafeteria in which the topic of technology will be discussed.

IX. Board Presentation

1) **District Goal #3: Career Education Program Evaluation 2022** - Kristin Fox, Assistant Superintendent of Curriculum & Instruction, Stephanie Smith, Director of School Counseling, Jean O'Connell, Director of Special Services and John Brum, RHS Teacher: Science and Senior Internship Program

Assistant Superintendent Fox reviewed District Goals 1&2 and introduced the presentation by giving a brief overview of the steps that led to District Goal #3: Career Education Program Evaluation. Ms. Fox discussed the benchmarks of the goal including the subgoals. Ms. Fox noted that for this presentation subgoal 1.1.B: Increase opportunities for students to explore career, college and vocational opportunities would be the focus

Ms. Fox discussed the current program and evaluation of career and education programming and how to encompass and develop it in all areas of the curriculum.

Director of Special Services, Jean O'Connell, discussed the Work Skills program available for students with disabilities in which skills are taught directly in the school and community at local job sites.

Director of School Counseling, Stephanie Smith, discussed the Vocational program and various ways to expose students to different careers citing career fairs, career days and other various activities that are related to those events. Ms. Smith also discussed interest inventories and career exploration through the classroom.

Ms. Smith identified the committee members involved with the program, the evaluation process including the committee, comparison and current program analysis. Ms. Smith discussed the collection of information in order to research support and best practices, the research of other school districts in New Jersey including use of technology and partnership programs noting that the research resulted in five program evaluation committee recommendations.

Ms. O'Connell, provided further detail into the expansion of the vocational skills/ work program for students with disabilities. Focuses for the program include community engagement, transition between the school and community and an increase of opportunities for the students.

Ms. Smith discussed various ways to increase awareness of the pathways to careers and Ms. Fox discussed the expansion of opportunities for students to engage in college or career related activities.

Ridge High School Science Teacher, John Brum, discussed the Senior Internship Programs available to the students, provided a history of its development, benefits, participant numbers and provided some of the comments made by Internship Hosts along

with comments made by participants in the program. Mr. Brum discussed future goals for the Senior Internship Program.

Emily Gray, RHS Class of 2020 graduate, Sarah Skalski, RHS Class of 2021 graduate and Julia Schnarr, RHS Class of 2021 graduate provided shared their personal experiences with the internship program and their internship hosts.

Assistant Superintendent Fox thanked everyone for their participation in the presentation.
