RESOLVED, that the governing body of the Bernards Township Board of Education, in The County of Somerset, in the State of New Jersey hereby increased its bid threshold to \$36,000.00; and be it further

RESOLVED, that the governing body hereby appoints Rod McLaughlin as the Qualified Purchasing Agent to exercise the duties of a purchasing agent pursuant to N.J.S.A. 18A:18A-2b, with specific relevance to the authority, responsibility, and accountability of the purchasing activity of the Board of Education; and be it further

RESOLVED, that in accordance with N.J.A.C. 5:34-5.2 the Board of Education Secretary is hereby authorized and directed to forward a certified copy of this resolution and a copy of Rod McLaughlin's certification to the Director of the Division of Local Government Services.

Representatives from districts who currently have mandatory random drug testing in place will be invited to attend the June Policy Committee meeting. Also on the agenda will be information on the SACs case loads, a review of the April 2014 Strauss Esmay Policy Alert, and a discussion of policy implications of E-cigarettes.

Board comments included establishing the consequences for a drug testing program, and removal of a student from an activity if a test is positive.
