VIII. Public Hearing 2020-21 Budget

1) **2020-21 School Budget Presentation** – Nick Markarian, Superintendent and Rod McLaughlin, Business Administrator/Board Secretary

Mr. McLaughlin presented the financial aspect of the district's proposed budget for the 2020-21 school year. Mr. McLaughlin detailed the anticipated revenue and expenditures, fund balance, capital projects, budget/state aid/tax histories, new tax rates, and a breakdown of general education, special education, support services and transportation expenditures. Mr. Markarian reviewed how the budget supported district goals and the anticipated staffing adjustments for budget year 2020-21.
